7. AUSIEX Portfolio Reporting Services Adviser Agreement (together the "Agreement")

These Terms of Service are specific to the AUSIEX Portfolio Reporting Service.

Definitions contained in the AUSIEX Terms of Access apply.

1. THE ADVISER'S COMMITMENT

- 1.1 The Adviser must for the duration of this Agreement:
 - a. maintain an AUSIEX Share Trading Account for the Client for which this Service is being provided;
 - b. the Client must be party to a CHESS Sponsorship Agreement;
 - c. provide to AUSIEX full disclosure that is correct and is not misleading, of all information required by AUSIEX in order to provide the Service; and
 - d. notify AUSIEX in writing within five (5) Business Days of any change from time to time in any information provided to AUSIEX in the application form or in connection with the Service.
- 1.2 The Adviser will promptly advise AUSIEX of any material change in circumstances which might affect their ability to meet their obligations under this Agreement, or AUSIEX's performance of the Services or necessitate changes in the investment holdings operations of the Portfolio Reporting Service account.

2. FEES

- 2.2 The AFS Licensee will pay AUSIEX for the Services on the basis of the Fees. 4 ROLE OF AUSIEX AND SERVICES TO BE PROVIDED

- 4.1 Subject to AUSIEX receiving the information it requires and on time from the Client's authorised representative and third party data sources selected by AUSIEX, AUSIEX will perform the following portfolio reporting services for the Client in respect of the Client's investments based on the information obtained by AUSIEX from the authorised representative and those third party data sources:
 - at a minimum, an annual report in relation to the Client's Investments including:
 - a market value report;
 - a transactions summary report;
 - an income and expense report; and
 - a sales summary report, in those forms and containing that information as AUSIEX may from time to time reasonably determine;
 - annual taxation reporting in relation to the Client's Portfolio Reporting Service account; and
 - The Service may also include other services as notified to the Adviser by AUSIEX from time to time.
- 4.2 AUSIEX will only provide the Service in respect of the Client's investment in relation to assets or classes or types of assets (including money) as AUSIEX determines from time to time (either generally or in relation to a particular Client).

Fee Schedule (including GST)
